


## Instructions for Attaching Professional Development Calendars/Plans in ASSIST

Title I Schoolwide and Targeted Assistance schools are required to submit their professional development plan/calendar as part of their School Improvement Plan. In order to meet this requirement in ASSIST, schools will need to upload the file in the School Additional Requirements Diagnostic, found on the Diagnostics & Surveys tab.


These Diagnostic and Survey Tools will assist your institution in collecting valuable data to inform your improvement efforts. We encourage you to use them regularly to gauge your progress.
